# The Surrogacy journey

1. Intake and prescreening of the surrogate
2. Intake with intended parents
3. Matching of surrogate and intended parents
4. Medical and psychological screening of surrogate and intended parents
5. Contract phase with independent legal counsel
6. Embryo transfer and pregnancy
7. Parentage proceeding during the second trimester of the surrogate's pregnancy that results in an order declaring the intended parents to be the child's parents and directing that they be listed on the child's original birth certificate
8. Delivery of the baby, who goes home from the hospital with the intended parents

## Eligibility

# Requirements for NYSC Surrogates

- Between the ages of 21 and 45
- U.S. citizen or lawful permanent resident of NY, NJ or VT
- At least 1 prior term pregnancy without significant complications
- Delivered less than 6 children
- Had less than 4 C-sections
- Had less than 2 miscarriages
- Had less than 2 stillbirths
- In good physical and mental health
- BMI below 35
- No diagnoses of Hepatitis B
- No STDs or HIV
- No ongoing issues with eating disorders
- No issues with severe post-partum depression
- Must provide informed consent for surrogacy
- Consumes no more than 1 alcoholic beverage per day
- Drug-free (including marijuana)
- No smoking cigarettes
- No tattoos or body piercings within last 12 months
- No prior indicated findings of child abuse
- No disqualifying criminal convictions
- Not on probation or parole
- Not a current victim of domestic violence
- Has a stable family environment
- Has consent of spouse, if married
- No travel to Zika-infected country within last 12 months

We conduct extensive screening of potential surrogates before matching regarding:

- Strict eligibility requirements
- Child Abuse/Neglect checks
- Criminal background checks
- Obtain OB/GYN medical records
- STD screenings
- Drug tests
- DMV abstracts
- Credit report
- Home visit with surrogate

Referrals for intended parents to resources for obtaining donated ova, sperm and/or embryos if their fertility clinic does not offer these services.

We conduct an independent review of the surrogate's medical insurance prior to matching.

We provide personalized matching services that pair intended parents with compatible, like-minded surrogates.

We offer thoughtful referrals to experienced mental health providers for psychological screening procedures before embryo transfer.

We provide referrals to experienced Assisted Reproduction Technology law attorneys for contract drafting and parentage proceedings.

We offer referrals to experienced Estate Planning attorneys who are also familiar with Assisted Reproduction.

We assist in coordinating the purchase of insurance for the surrogate, including medical, life, disability, etc. after matching.



We provide independent escrow management services for the funds to be dispensed during the surrogacy journey, which are handled internally by attorneys adhering to strict ethical requirements and who have experience handling large escrow accounts.

Our agency is fully independent in the process and does not provide legal representation to surrogates or intended parents.

It is our passion to provide ongoing guidance and emotional support for intended parents and surrogates throughout the surrogacy journey.
